8 1) According to ordinance 6086, every bonafide shall be allowed to keep terms for the given semester in a program of his enrolment only if he fulfills **at least seventy five percent (75%)** of the attendance taken as an average of the total number of lectures, practicals and tutorials. It is mandatory for every learner to have **minimum 50% attendance for each course.**

**2) According to Ordinance 125 to keep a term at a college or a recognized institution, an undergraduate must complete, to the satisfaction of the Principal or the Head of the institute the course of the study at the College or Institution prescribed for such terms for the class to which such undergraduate belongs.
